In Si Zhu Yue Music: A Historical and Ethnomusicological Perspective on Jiangsu's Cultural Identity, <u>Junlong Li and Kritsakorn Onlamul</u> explore the historical development and contemporary role of Silk and Bamboo music in Jiangsu Province, China. The study traces the evolution of this musical tradition from the Tang and Song dynasties to its modern adaptations and challenges in a globalized world. The research underscores the importance of preserving traditional music as a means of maintaining regional cultural identity.

The fourth article, The Role of Welfare Laws in Supporting Thailand's Poor: An Analysis of Social Protection Systems, by <u>Somporn Siripan</u>, critically examines Thailand's welfare policies and their effectiveness in reducing poverty. The study evaluates key social protection mechanisms, including universal health coverage, social security, and cash transfer programs, highlighting gaps in coverage and implementation.
